



Christmas Card Competition 2021 – Terms and Conditions

From 25th October 2021 until 30th November 2021, we are running a Christmas card competition for children and young people. There are two categories:

- Category One children aged and up to 8 years old
- Category Two children and young people aged between 9 16 years old

One winner from each category will be chosen week commencing Monday 13th December by a staff vote. The winning designs will be produced for the 2022 Christmas collection.

Unfortunately, children and young people related to MND Association employees cannot enter the competition.

If you are the child or young person entering:

You're probably thinking what are "terms and conditions"? Well, don't worry, we've put some information above and below for your parent, guardian or carer to read. All you need to think about is 3 things:

- 1. Design an amazing card, making it as colourful and fun as you can (but please ensure it is suitable to go through the printer so no sticky items)
- 2. Make sure you don't copy it from anything we much prefer your own ideas.
- 3. Make sure you check that it's ok to enter and ask your parent, guardian or carer to send us your entry before 11th December.

Now, please show the rest of this to your parent, guardian or carer before you start.

If you are the parent, guardian or carer.

This competition is open to children and young people living in the England, Wales, the Channel Islands, Isle of Man and Northern Ireland. Submission of an entry will be taken to mean acceptance of the design being used and, if necessary, amended (e.g. for printing reasons). A maximum of one entry may be submitted per person. Late entries will not be accepted. No responsibility can be accepted for lost entries. We regret that we will be unable to return any entries.

The winning entry in each category will be the picture that is judged to be the most visually appealing and original. The decision of the judges is final, and no correspondence will be entered unto. The winner will be notified within 28 days of the closing date of the competition. The winning entrants will be supplied with 3 packs (each of 10 cards) of their winning design, free of charge. Prizes are non-transferable and there are no cash alternatives.

Please can we ask, if you're sending us an entry by post, that you ensure the card is of a flat design and does not have any sticky items on it. We need to ensure all our card entries are suitable to go through a printer.

If you are submitting your child's entry via our website or by email, please make sure you keep hold of the original copy as we may need it when we come to printing the winning cards.

Please can we ask that you submit your child's entry and include your email address as well as their name and age - this can all be put on their entry.
